



Plumbing Contractor's Licence Application Guidelines

Enquiries about completing your application, where the information is not contained in these Guidelines, should be directed to the Licensing Team on (08) 9282 0478.

Enquiries regarding gasfitting permits should be directed to EnergySafety on (08) 9422 5200.

1. Authorisation

To carry out water supply, sanitary and drainage plumbing work in Western Australia you must hold either a plumbing contractor's licence or a tradesperson's licence issued by the Plumbers Licensing Board ("the Board"). The Board issues licences under the *Water Services Licensing (Plumbers Licensing and Plumbing Standards) Regulations 2000* ("the Regulations").

A plumbing contractor's licence authorises the holder to:

- carry out the plumbing work specified on the licence;
- exercise general direction and control over the carrying out of authorised work by the holder of a tradesperson's licence;
- supervise the carrying out of such work by an apprentice; and
- certify plumbing work.

In accordance with the Regulations, to be eligible to obtain a plumbing contractor's licence an applicant must:

- demonstrate to the Board that they are:
 - competent in carrying out water supply, sanitary and/or drainage plumbing work; and
 - a fit and proper person to hold a licence.
- provide to the Board two (2) certified passport sized photographs.

2. Supporting Documentation

Please note: All supporting documentation is required to be either certified copies or the original documents.

2.1 Proof of Competency

To be eligible to obtain a plumbing contractor's licence you must:

- hold a Statement of Competency as a water supply plumber, sanitary plumber or drainer issued by a registered training provider or an equivalent Western Australian qualification;
Or
- hold a Certificate of Reciprocity in water supply, sanitary and/or drainage plumbing at independent certifier level;
Or
- hold a qualification recognised by the Board at "independent certifier" level and demonstrate that you have at least six (6) years practical experience in water supply, sanitary and/or drainage plumbing work.

If you hold a qualification recognised by the Board at independent certifier level and that qualification was not obtained in Australia or New Zealand, to be eligible to obtain a plumbing contractor's licence you must:

- hold a tradesperson's licence for at least three (3) months;
- Or
- have completed to the satisfaction of the Board an approved familiarisation program in relation to plumbing work in Western Australia.

If the qualification recognised by the Board is not at independent certifier level to obtain a plumbing contractor's licence you will need to undertake 'advanced craft' training and obtain a qualification in water supply, sanitary and/or drainage plumbing.

To demonstrate six (6) years practical experience, you need to provide detailed written references from previous employers stating the period of the employment together with specific examples of plumbing work that you have carried out.

If you hold a current licence in another Australian State/Territory or New Zealand you may be entitled to apply for a licence under the *Mutual Recognition (Western Australia) Act 2001* or the *Trans-Tasman Mutual Recognition (Western Australia) Act 2007*. Refer to part three (3) of these Guidelines (page 3) for further information about applying for a licence under these Acts.

Further details about competency requirements can be obtained from the Licensing Team on (08) 9282 0478.

2.2 Re-Issue of a Licence

If you have previously held a plumbing contractor's licence issued by the Board, or equivalent organisation, in Western Australia, you will also need to make a statement declaring the extent of plumbing activity you have been involved in since your plumbing contractor's licence (or other) expired by completing section five (5), Re-Issue of a Licence, of the application form on page six (6).

To be eligible for a licence you may be required to undertake retraining. If you are required to undertake retraining a member of the Licensing Team will contact you.

2.3 Fit and Proper Test

To be eligible to obtain a plumbing contractor's licence, the Board must be satisfied that you are a fit and proper person to hold a licence. To enable the Board to assess your application you are required to provide:

- a current National Police Certificate;
- details of any charges against you (including pending);
- details of any disqualifications from holding an occupational licence and
- details of two referees.

2.3.1 Police Certificate

You must provide a National Police Certificate, which is **no more than three (3) months old** at the time of lodging your application. A National Police Certificate lists a person's criminal history (if any), recorded in any state or territory of Australia **Original or Certified Copy only**.

Western Australian Applicants

If you have lived in Australia for more than two years and currently reside in Western Australia you must apply for a National Police Certificate in person at your local Australia Post outlet and provide suitable identification. Please visit www.police.wa.gov.au for further information.

Applicants from other Australian States/Territories/New Zealand

If you are not currently living in Western Australia, but have been living in Australia for more than two years you can apply for a National Police Certificate in person at the police service of the state or territory in which you currently reside.

Applicants from Overseas

If you are not currently living in Australia or have been living in Australia for less than two years please contact the Licensing Team on (08) 9282 0478 to discuss your application.

2.3.2 Charges

As part of your application you are required to provide the details of any charges that have been made against you. You are required to provide the name of the court and the state or territory in which the charge has been made as well as the nature and circumstances of the alleged offence.

2.3.3 Disqualifications

You are required to provide the details of any disqualifications from holding an occupational licence that have been made against you including any suspensions of occupational licences as well as applications for occupational licence that have been refused. You are required to provide full details of all of the particulars including the name of the type of licence, the issuing authority, the date of the disqualification and the reason the licence was refused, suspended or cancelled.

2.4.4 Character References

To support your application you are required to provide the details of two referees, that have known you for at least 12 months, who can substantiate your character. It is preferable that your referees are previous employers. Prior to submitting your application, please notify your referees that they will be contacted as part of the application process. No person under the age of 18 years or a relative can be nominated as a character reference.

2.4 Provision of Photographs

To obtain your plumbing contractor's licence you will need to provide two (2) identical photographs of yourself attached to your application. The photographs must be:

- passport sized (45mm length x 35mm width);
- a full front view of your head and shoulders; and
- less than one month old at the time of submitting the application for plumbing contractor's licence.

A competent witness (refer to page 11 of this booklet for a list of competent witnesses) must complete the declaration on pages eight (8) and nine (9) as well as sign the reverse side of the photographs. You will need to ensure that you provide identification of yourself to the competent witness completing the declaration to the value of 100 points (refer to the declaration on pages eight (8) and nine (9) of this booklet for a list of documentation that can be used as identification and the point value assigned).

Please note that the quality of the photographs provided will have a direct impact on the quality of the image that will appear on your licence card. Please ensure that the photographs you provide are clear with the image focused. **Video camera, e-mailed or photocopied images will not be accepted.**

The Board may refuse to issue a licence to you if:

1. the Board is not satisfied that the photograph is a current image;
2. the photograph is unclear; or
3. the photograph would not serve its purpose if it were included as part of the licence identification card.

Photographs will remain the property of the Board and will not be returned to applicants under any circumstance.

3. Mutual Recognition

If you are licensed at independent certifier level elsewhere in Australia or New Zealand and that licence is current at the time of lodgement of your application you are entitled to apply for a plumbing contractor's licence under the *Mutual Recognition (Western Australia) Act 2001* or the *Trans-Tasman Mutual Recognition (Western Australia) Act 2007*. These Acts provide for the recognition of occupational licensing in other Australian states and territories and New Zealand.

To apply for a licence under mutual recognition you need to provide a **certified copy** of your current licence from the State/Territory or New Zealand where you are licensed to carry out plumbing work. You must also complete the Mutual Recognition Statutory Declaration on page ten (10) and declare it before a competent witness (refer to page 11 of this booklet for a list of competent witnesses).

When the Board has received your completed application together with all supporting documentation under the *Mutual Recognition (Western Australia) Act 2001* or the *Trans-Tasman Mutual Recognition (Western Australia) Act 2007* you are deemed to hold a plumbing contractor's licence in Western Australia until a decision about your application has been made. Please visit: www.licencerecognition.gov.au for further information about licence equivalency.

If you are not applying for a licence under Mutual Recognition you are not required to complete the declaration on page ten (10).

4. Fees

4.1 Application Fee

An application fee of **\$50.00*** is payable at the time of lodging an application for plumbing contractor's licence with the Board.

* Application fee is non-refundable.

* Fees current at May 2009

* GST is not applicable.

4.2 Licence Fee

The fee for a plumbing contractor's licence is \$500.

The licence fee must be paid at the time of lodging an application for plumbing contractor's licence with the Plumbers Licensing Board. If your application is unsuccessful the licence fee will automatically be refunded and posted to the address specified on the application form.

If you hold a **current Western Australian tradesperson's licence** you may be entitled to receive a refund of the licence fee proportionate to the period remaining. If you are entitled to this, the refund will be automatically processed and forwarded to you.

All licences are valid for 3 years from the date of approval.

5. Lodging Your Application

Your application cannot be processed unless all of the relevant information and supporting documentation is provided. At the time of lodgement, your application should be complete, signed and witnessed.
